 - Outreach obstacles: It is difficult to reach individuals who would benefit most from our products as the organizations they are connected to have extensive review processes or the reverse, no processes at all, which results in blockages to access.
 - In addition, we find that reaching new underserved customers and building trust for our innovative fingernail clipper has created unique challenges which often requires one-on-one training.
 - Lower than projected sales increases the cost of production: Despite increased cost per unit due to lower volume of sales, ClipDifferent has maintained its quality assurance.
