During the second year of operations for Platform Commercial Real Estate, SBC ("Platform") we are proud to have taken meaningful steps toward advancing our public purpose, which is "to democratize access to real estate development as a driver of community power."

We have provided a number of services that meet that purpose (1i and 1ii).

- Supported a social enterprise catering company in identifying a new kitchen to lease
 with a future option to buy. Work included a tailored leasing approach and rent ramp
 up to allow them to grow into the building over time. Completed at a discounted rate in
 collaboration with a pro-bono attorney.
- Consulted for a nonprofit affordable housing developer and neighborhood organization on a financial approach for community oriented commercial space in a new development.
- 5. Initial feasibility analysis for a future multistakeholder redevelopment led by a nonprofit land trust.
- 4. Assisted another Public Benefit Corporation in purchasing a building for their operation, after many decades of renting.
- 5. Assisted a woman owned sustainable architecture firm in acquiring a multi tenant building to preserve space for existing tenants and create an office for themselves in the vacant storefront unit.
- 6. Supported a Latino community organization in initial feasibility for a major potential acquisition.
- 7. Completed financial analysis to assist a for profit arts center seeking conversion to cooperative or nonprofit ownership.

We have not had any significant barriers to achieving our intended benefit in 2024. (1-iii) Platform's Board of Directors consists of Renee Spillum, Erin Heelan, and Marca Sung. We approved this document via unanimous vote at our Shareholder Meeting on January 17, 2024
