<u>Stated Mission</u>: To create commercial products from existing food waste rather than from new resources, in order to preserve the natural environment for the benefit of current and future generations.

The ways in which the corporation pursued and created the specific public benefit stated in its articles: Most of the corporation's work in 2023 was devoted to engineering work to commercialize the NETZRO patent pending equipment and is now complete and ready for market. Business development initiatives continue to raise awareness on the benefits of food/beverage manufacturers purchasing equipment to safely capture and convert food byproducts into new sustainable ingredients at scale. Research and development in collaboration with food manufacturers continues for new food products made with (a) upcycled spent grain recovered from Twin Cities breweries and distillers, (b) upcycled apples from MN cidery, and (c) upcycled calcium & collagen from eggshells recovered from egg-breaking operations in Minnesota.

The extent to which that specific public benefit purpose was pursued and created: As a founding member of the Upcycled Food Association, NETZRO engaged in the creation, deployment and sale of the upcycled food certification https://www.upcycledfood.org/certification.



NETZRO continues to promote the use of technologies to process certified upcycled ingredients with various food and beverage companies.

Any circumstances that hindered efforts to pursue or create the specific public benefit: Though NETZRO did receive some funding from an international foundation to continue development of the technology, the need for capital continued to be a challenge and a factor that has slowed the company's progress.
