

The B Impact Assessment was developed by B Lab, which is independent of the corporation, its board of directors, and its officers. The board of directors of the corporation has approved the corporation's report for the year ended December 31, 2023.

Under the BImpact Assessment, the corporation has determined that it has served the general benefit in

- The corporation is black woman owned and managed;
- The corporation provides employment, mentoring, and skill development to teens, young adults, and individuals returning to the community following incarceration in an economically challenged community;
- The corporation serves an underserved community and works with racially diverse vendors and
- The corporation provides a venue for communication regarding community issues and healing

The corporation's efforts to pursue general benefit were not materially hindered during 2023. The corporation commenced operation of its bakery and cafe during 2022.
