Article I – Name of the Cooperative (Required)

Article II – Purpose of the Cooperative (Required)

Article III – Principal Place of Business (Required)

List a complete street address or rural route and rural route box number of the principal place of business. A post office box by itself cannot be accepted as the address of the principal place of business.

Article IV - Duration

The cooperative has a perpetual duration unless stated otherwise.

Article V – Registered Office Address and Agent (A Registered Office Address is Required)

A registered office address in Minnesota is required. List the complete street address or rural route and rural route box number for the registered office address. A post office box by itself is not acceptable. If you have a registered agent, list the full name of the agent located at the registered office address. An Agent is not required.
