All limited partnerships governed under *Minnesota Statutes*, Chapter 321 are required to file an annual renewal once every calendar year. Filing this Annual Renewal does not satisfy any other legal requirement. If Minnesota statutes or rules require a filing with another office, you must submit that filing separately.

If changes to the name or address are necessary, an amendment along with the annual renewal form and the applicable filing fee is required.

- 1. File Number: List the file number issued by the Minnesota Secretary of State.
- **2. Home Jurisdiction:** (Required) List the state or jurisdiction in which this organization is organized.
- 3. Partnership Name: (Required) Provide the name of the partnership in the jurisdiction in which it is organized.

Reporting Business Ownership Information
