Music Mayhem is a for-profit corporation organized for the purpose of developing and selling its proprietary music guessing game and any related products and services. Our company's specific benefit purpose is to financially support research, advocacy and high quality care for individuals with Alzheimer's and related dementias. Our social mission is to make Alzheimer's a distant memory, one song at a time. To fulfill its purpose, the company donates a portion of proceeds from sales of its products to qualified organizations no less frequently than annually. The corporation will also donate products and services to organizations dedicated to Alzheimer's disease research, care and/or advocacy.

#3 SBC Statement

The company was not profitable in 2019 but designated a portion of revenue from our live performances at several of our bar venues where we sponsor multiple week Music Mayhem league competitions as part of our fundraising effort for the Alzheimer's Association of Minnesota.

We contributed \$435 on July 23rd 2020 to the Alzheimer's Association of Minnesota as part of their annual Longest Day fundraising event.

The company also donated the use of two of their Music Mayhem mini-computers to the adult memory care programs at Open Circle Adult Day Services at their North Minneapolis and Hopkins locations at an estimated value of \$350 each.

We also donated 12 copies of our board game (\$30 value) as prizes at our live performance events throughout the year.
