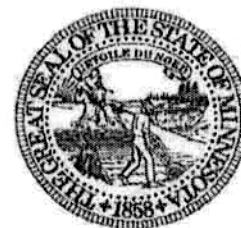

The Board of Directors of Local Blasts GBC chose and adopted again BCorp as our third-party standard and determined it to be independent.

During calendar year 2019, we completed development of our proprietary hardware and software for our innovative Sweepstakes Wheel platform, and we also tested the platform at real venues including a leading auction site and a major farmers market in Minneapolis. Recently we have developed brochures and other marketing materials and have commenced marketing toward targeted commercial and charitable organizations.

Our sweepstakes system has been designed and developed for both commercial and charitable uses, with our charitable clients receiving a percentage of all sweepstakes drawings sponsored by them.

We believe that the B-Corp standard we are using is the most cost-effective and appropriate for our Company. Our system can influence the charitable giving sector by eliminating fraud in charitable sweepstakes transactions and drawings. We also believe use of our "Wheel of Giving" sweepstakes platform will increase charitable contributions to our charity clients due to its exciting influence with donors and others. Our targeted demographic beneficiaries include both commercial businesses and charitable organizations of all types.

Our third-party standard is being applied in a manner consistent with its application in our prior report.

As a small corporation with only one employee, it is difficult for us to satisfy or improve certain metrics outlined by our assessment standard, but we intend to address such challenges in the future.
