Magaca aad qaadatayo: Haddii aad u xaraysay Shahaadada Magaca aad Qaadatay ama Shahaadada wax ka beddelka Magaca aad Qaadatay, waa inaad ku soo daabacdo "wargeys sharci ah" oo ku yaalla degmada uu ganacsigu ku yaallo. Waa inaad ku soo daabacdo qoraalka Shahaadada ama Shahaadada wax laga beddelay laba daabacadood oo isku xigta (laba maalmood oo isku xigta haddii uu wargeysku yahay maalinle; laba toddobaad oo isku xigta haddii wargeysku yahay toddobaadle).
