**Cloudburst, SBC** ("Cloudburst") was incorporated on January 9th, 2018 as a Specific Benefit Corporation under Minnesota's Public Benefit Corporation Act (the "Act").

Pursuant to Section 304A.101 of the Act, Cloudburst's specific public benefit purpose is:

# To enable fulfilling and flexible careers in technology and entrepreneurship, with an emphasis on underestimated communities.

We believe that careers in technology and entrepreneurship play a key role in creating fulfilling lives by providing the opportunity for flexibility, autonomy, and craftsmanship. Humans thrive in these conditions. We are on a mission to make these careers more readily available to people of all backgrounds, particularly those who have been underestimated (women, people of color, and LGBTQ+). We also aim to reduce the barriers to founding and scaling tech companies and technology-enabled businesses by making software product development more accessible and affordable.

#### REPORT

For the period from January 1, 2022 to December 31, 2022, Cloudburst pursued the specific public benefit purpose stated in its articles of incorporation in the following ways:

#### With our team: Hone Your Craft. Love Your Life.

- 1. We hired 4 employees
- 2. We paid team members for 1,243 hours (\$60,000) of Cloudburst X time to work on their own projects and community initiatives.
- 3. We held our first Cloudburst X internal hackathons
- 4. We paid \$14,000 in bonuses to team members who exceeded their core hours commitment
- 5. We continued to pay revenue share bonuses to all employees
- 6. We continued monthly team meetings to share financial results and business strategy
- 7. We established a Family and Medical Leave policy, including 4 weeks paid FML
- 8. We improved health care plan options and increased our contribution for 2023

#### With our clients: Get Started.

1. We invested \$66,000 in services in our clients through our Shared Success Agreement. Since 2018 we have invested \$517,000.

- 2. We branched out into Founder Coaching and No-Code development services to reach a broader market of early-stage founders.
- 3. We updated our Clarity Canvas framework for helping founders evaluate their app ideas and facilitated 19 no-cost sessions.

#### In the community: Bold North.

- 75% of our core product development team are bootcamp graduates
- We hosted sessions for founders during Twin Cities Startup Week
- We built the ForgeNorth Angel Basecamp content library for Angel investors
- We hosted community events in our office local tech meetups and founders
- We launched a blog series "Ok, But How?" featuring the stories of underestimated founders and published 7 interviews
