STONE SALOON, SBC d/b/a WALDMANN 2022 MN PUBLIC BENEFIT CORPORATION REPORT

Stone Saloon, SBC d/b/a Waldmann ("Waldmann") is a Minnesota specific benefit corporation having its principal place of business in the oldest surviving commercial building in the Minneapolis/St. Paul metropolitan area, a solid limestone structure that originally housed the German lager beer saloon of Bavarian immigrant Anton Waldmann between 1857 and 1863. After Waldmann returned to Germany in 1885, the building was rehabilitated as a home, and by 2008 it had fallen into severe disrepair. The building is included in numerous historic site surveys, and in 2015 was designated as a Heritage Preservation Site by the Saint Paul Heritage Preservation Commission.

Waldmann was incorporated in March of 2016. In 2017 we completed the restoration of the historic structure and construction of a "brew barn" addition to the rear—and then opened business in October 2017 as a historically-themed brewery/tap house. In addition to preserving and showcasing this historic building and site, we now serve traditional German lagers and simple, high-quality fare appropriate to the mid-19th century Minnesota frontier.

Waldmann's articles of incorporation state that it has been organized to promote the following specific benefit purposes:

- 1. Educate the public regarding mid-19th century American and Minnesota history, including its diverse German-American and other immigrant cultures; and
- 2. Maintain, preserve and provide routine public access to the Anthony Waldmann House/Saloon in accordance with the preservation program adopted by the HPC and the United States Secretary of Interior's Standards of Rehabilitation.

2022 was Waldmann's fifth anniversary of operation. Although the COVID pandemic is now two years behind us, many of the face-to-face gatherings previously held at Waldmann by the Ramsey County Historical Society and other organizations are now conducted on line. Nevertheless, in 2022 were able to conduct the following activities supportive of our purposes:

- On February 24, a presentation and tour given to 24 Minneapolis Community Education students on the history of German breweries and lager beer in America, entitled "How Lager Saved America."
- On the first Monday of March, April, May and June, free performance space for Bath Mouth
 Theatre, a local nonprofit theater group performing historically-based plays in the Twin Cities.
- On June 18, President/CEO Tom Schroeder presented "Decisions that Change Lives: The History of Waldmann and its Reopening," to a gathering at Carleton College in Northfield, MN.
- On August 30, a presentation to a **group of 25 from Edina Senior Center on "Civil War Saloons of Saint Paul,"** including a history of Waldmann and its restoration.

- On August 31, an American Craft Council Tour & Happy Hour, showcasing the aspects of craft entailed in Waldmann's original construction and restoration work. Proceeds from the event benefitted the ACC.
- On September 8, a fundraiser of the Minnesota International NGO Network, providing the space at no charge and presenting on Waldmann's 19th century international immigrant roots.
- On December 6, a holiday gathering of reenactors of the Civil War Minnesota First Volunteer Infantry at no charge, who also dressed in costume and interacted with our other guests.
 (Waldmann's stonemason was a Captain in the MN 5th Volunteer Infantry.)
- From September through December, we provided free meeting and organizing space to 4 local nonprofit neighborhood organizations that rallied to save the 1852 Justus Ramsey House, 252
 West 7th, Saint Paul, which was part of the Saint Paul City Council's 2015 Pioneer Era Limestone Buildings designation along with Waldmann.
- In addition to occasionally donating beer, T-shirts and other swag for charitable fundraisers,
 Waldmann donated six charitable history tours and beer tastings as silent auction items,
 including to Historic Saint Paul, Ramsey County Historical Society, Center for Irish Music, and the
 Saint Paul Curling Club.
- We continue to support local artists specializing in period and folk music appropriate to Waldmann's setting, including the music of the logging camps, Irish/Gaelic/Canadian folk, American blues and Tin Pan Alley.
- Waldmann's 6-day, family-focused Oktoberfest featured 18 performances of German-American music and other traditional German-American cultural activities.
- Throughout the year, on innumerable occasions, owner Tom Schroeder provided ad hoc tours to guests describing various aspects of Waldmann's family and building history, the history of lager beer in America, and retelling the story of Waldmann's redevelopment.
- We expended a significant portion of our income maintaining and preserving the structure of the Anthony Waldmann Saloon/House, a St. Paul Heritage Preservation Site.
- Most significantly, we provided daily and routine access to an estimated 34,000 unique visitors, all of whom experienced Waldmann first-hand as a "living museum" operating in a manner consistent with its historic use. Numerous visits included impromptu tours to guests and passers-by, always without charge.

In the coming year, Waldmann will continue to provide ad hoc and scheduled tours, programming supportive of its specific benefit purposes, meetings and events space to nonprofits and affinity groups, a venue for folk and period musicians, special gathering space, and information and daily access to its unique history and architecture.
