Annual Benefit Report of J. Benson Construction, GBC

A Minnesota General Public Benefit Corporation

- J. Benson Construction, GBC filed and became a Minnesota General Benefit Corporation under the Minnesota Public Benefit Corporation Act (the "Act") on October 23rd, 2023. Pursuant to Section 304A.101 of the Act, J. Benson Construction's general public purpose as stated in its Articles of Incorporation is:
 - J. Benson Construction, GBC is a general benefit corporation as set out in Minnesota Statutes Chapter 304A. While we are a GBC our goals include making the world a better place by creating construction careers for people from underserved communities.

During the period covered in this report, October 23, 2023 to December 31, 2023, J. Benson Construction, GBC pursued and achieved the general public benefit purpose stated above in the following ways:

J. Benson Construction Corporation, a Minnesota corporation since September 28, 1988, completed its conversion to a General Public Benefit Corporation. Our legal name as of 10/23/23 is J. Benson Construction, GBC d/b/a J. Benson Construction.

Continued to Train a Summit Academy graduate and assisted them in becoming a member of the Carpenter's Union. They have attended union apprenticeship training while working as a full time carpenter and is well on her way to their next union apprentice level.

We hired a Project Engineer to help grow our Self Performed Carpentry division and assist the Director of Self Performance we hired last quarter. This has allowed us to take on more self-performance Carpentry work and hire several more union carpenters. This will allow us to pursue additional hiring in accordance with our stated objective above.

We recently added an Intern to our team who is studying to be a project engineer. We set up our Intern and new Project Engineer with the equipment and training needed to be successful.

J. Benson Construction, GBC's Board of Directors agreed to use the third-party verification system of B Impact Assessment. B Impact Assessment has been chosen to measure and help manage J. Benson Construction, GBC's social and environmental impact against industry peers as we strive to meet our stated public benefit goals.
