# Ecotone's Creation of a General Public Benefit

(A) How the corporation has pursued general public benefit:

Mission: Ecotone Analytics GBC is a data analysis and communication company working exclusively with clients who want to measure, manage, and communicate their social or environmental impact.

Vision: Ecotone Analytics GBC is committed to expanding the use of social and environmental metrics in decision making for corporations, government, funders, and non-profits.

(B) The extent to which and the ways in which the corporation has created general public benefit include:

In calendar year 2023, Ecotone Analytics GBC helped create general public benefit through the following

Applegate, impact analysis of existing production standards - Conducted an impact analysis and estimated the various social and environmental impacts of Applegate's existing production standards - humanely raised, no antibiotics ever, organic, and grass-fed beef. The report considers the value of these production standards and to whom that value accrues. This work will support Applegate's efforts to both bolster and communicate their environmental impact

Boys and Girls Club, a 501(c)3 nonprofit organization - Ecotone Analytics is collaborating with Boys and Girls Club of America on a social return on investment and impact analysis, updating and evolving previous impact measurement efforts. Ecotone is discussing project goals, Club strategies and offerings, past evaluation efforts, and overall impact strategy with the BGCA team. Ecotone complements meeting insights with a systematic review and statistical analysis to understand and better model Club impacts. This work will support deeper understanding of the impact created at the

## CEMEX, impact measurement framework and monitoring guidelines - Ecotone is working with Cemex to understand the community benefits of their strategic philanthropy portfolio, organize the portfolio into a thematic taxonomy, and understand how expansion and management of community benefits can be material to the firm's business strategies. By better aligning social impact initiatives with CEMEX's core ESG strategy, Ecotone will help ensure more efficient resource allocation, which in turn will allow CEMEX's Social Impact team to effectively monitor and measure the outcomes resulting from their programs and initiatives.

**CDW, a digital equity giving portfolio analysis** – Continued to collaborate with CDW giving leadership on understanding the impact and opportunities for its philanthropic giving strategy focused on digital equity. Ecotone analyzed the portfolio to help leadership understand its performance against key community outcomes and employee engagement goals. This work has continued to help CDW giving leadership understand and monitor the impact created by its portfolio and position CDW as a leader in data-driven impact.

**CDW**, a supplier diversity strategy – Conducted an impact analysis on CDW's supplier diversity program. Ecotone's analysis helped CDW team members recognize how its supplier diversity program contributes to digital equity, helping to develop a cohesive narrative between CDW's business operations and philanthropic giving (see digital equity strategy above).

Entrepreneurship Fund IBW, a community development financial institution - Ecotone conducted an impact baseline analysis for the Entrepreneur Fund, analyzing the impact generated by the Entrepreneur Fund's current and planned services. This work resulted in a report that identified opportunities to protect, enhance, and communicate the impact created through its loans and services, which has helped Entrepreneur Fund clarify its position as an important resource to supporting and sustaining growing small businesses and entrepreneurs.

**Equinom, a plant-based food impact analysis** – Conducted a life cycle assessment of Equinom pea protein concentrates compared to conventional pea protein isolates to examine the relative environmental preferability across three primary indicators of environmental impacts, including greenhouse gas emissions, water consumption, and land use. This work helped Equinom understand major sources of environmental impact in pea protein processing.

**Forward Service Corporation, 501(c)(3)** – Ecotone conducted an impact analysis and social return on investment for Forward Service Corporation's (FSC) Upward Bound program. Ecotone worked with FSC staff to understand key data and types of outcomes generated by the program as well as developed communication materials aligned with impact measurement and management frameworks. This analysis helped FSC staff consider the long-term impacts of the program as they evolve program services. The findings were formatted in the Impact Overview for better communication of value to funders and stakeholders.

Friends of the Mississippi River, 501(c)(3) – Began conducting a wedge analysis to help the Friends of the Mississippi River team and partners forecast the expected economic and environmental impact from the adoption of selected continuous living cover crops under various time frames and growth assumptions. This work involved interviewing stakeholders and creating a feasibility report, helping build consensus, leverage various partners' expertise, and identify promising continuous living cover crops to research.

Land Bank Twin Cities, an affordable housing organization - The Land Bank captures strategic real estate opportunities through land banking, lending, brokering, technical assistance, and managing property to benefit people with low to moderate incomes, prioritizing people of color and populations facing barriers. In order to facilitate the development of LBTC's strategic plan for the next few years, Ecotone: (i) developed an analysis of Land Bank Twin Cities's performance over the last five years; (ii) assessed the key market needs and trends; (iii) interviewed selected stakeholders; (iv) developed a set of recommendations; and (v) posed strategic considerations for the future.

# Minnesota P-20 Education Partnership, an organization of statewide education, business, government, and private sector leaders - Ecotone worked with MN P-20

Education Partnership to conduct a review and analysis on dual enrollment programs in Minnesota. This involved reviewing the logic that connects dual enrollment programming to the desired outcomes, the known or unknown causal relationships within that logic, and the underlying assumptions linking the intervention to the outcomes. This analysis helped MN P-20 members to better understand and model program impacts and to advocate for resources to improve outcomes for PSEO students, and in particular students of color and Indigenous students.

(C) Any circumstances that hindered efforts to pursue or create general public benefit?

In the USA, 2023 was again marked by political rhetoric about ESG. State governors looking to core culture war points banned ESG or sent legal cases to the courts in the hopes of banning it outright. So we look to the EU, which is continuing to innovate and build up regulatory norms, and if multinational corporations want to do business there, they'll have to play along. The global economic instabilities have also slowed the pace and appetite for companies to try new things within their standard operations. The explosion of AI technology brings a lot of opportunities to scale impact but also big potential pitfalls in bad ideas and lazy strategic planning, resulting in another year of nonaction from corporate leaders.
